Applicants must have a **VALID PENNSYLVANIA PHOTO DRIVERS LICENSE**. A copy of your license will be made at the time of application.

Completed applications must be returned to the union office **NO LATER THAN Tuesday, April 30th, 2024**. All applications must be handwritten. No typed applications will be accepted.

Prior to applying, please review the following items:

1. Applicant must be at least 18 years of age to participate in the apprenticeship program.
2. Applicant must be a United States citizen.
3. Applicant must have a dependable form of transportation.
4. **Applicant must be a high school graduate or possess a G.E.D. A copy of the applicant's diploma or G.E.D. certificate must be provided at application time. Applicants must also provide a copy of high school grade transcripts or G.E.D. test scores prior to the interview process.**
Applicants that are scheduled to graduate after the application period must provide a copy of their high school diploma, high school transcripts, G.E.D., and G.E.D. test scores NO LATER THAN July 15th, 2024.
5. Applicant must be physically able to perform the work of the trade. The work is dirty and noisy, and the worker is exposed to the heat and cold. Work is active and strenuous with prolonged standing, much walking, reaching, and lifting and occasionally working in cramped or uncomfortable positions and at extreme heights.
6. **Term of apprenticeship:** Five (5) years of on-the-job training plus related classroom instruction several nights a week.
7. If selected for the Apprenticeship Program, applicant will be required to submit to both a pre-employment drug test and a physical/lifting exam.
8. Applicant will be required to take a written qualification examination.
9. Applicants who qualify based on the written examination will be granted a personal interview. Selection of apprentices will be based on qualifications without regard to race, color, creed, National Origin, or sex.
10. Upon completion of your application, you will be notified as to where and when to appear for your written examination.
